Update to the Rules of The Hungerford Club

Section Reports: Bowls, Tennis and Indoor Sports all as circulated

The reports from the Bowls, Tennis and Indoor Sports were circulated prior to the meeting.

The Chairman summarised the reports.

- The Bowls section has had another good year though they lost more trophies than they won!
 - The section continues to focus on encouraging new members and has been successful during the year.
 - They had a very successful fund raising day in aid of Royal County of Berkshire Bowling Association Benevolent Fund
- The focus of the Tennis section has been the refurbishment of Court 1. This is now complete.
 - Membership continues to be healthy, growing 15% over the year.
 - There have been more internal competitions as well as good participation in the local district leagues.
- The Indoor Sport section sees high usage of the snooker tables.
 - The Darts team has some new faces joining the core team.
 - Poker evenings are well attended and increasing numbers each week.
 - Ian Doolan asked to make some comments about the Indoor Sports section. These are included in Appendix 1.

The Chairman asked if there were any questions about the reports? No questions were asked.

Election of Officers and Committee to 2024/2025 Committee

Chris Scorey suggested that since we are reviewing the club's rules we could look to removing the need for a show of hands when there are no contested elections and appoint the sole candidate unopposed. He explained the requirement was known as the "Rex Knott" rule after a former Chairman who insisted it be added to the rules.

The suggestion was generally meet with agreement but a comment was made that the A.G.M. should have the opportunity to reject a candidate. The matter was deferred for discussion by the committee and to be brought forward with the other changes to the rules next year.

The Chairman asked if there was any other business that members wish to raise? Nothing was raised.

Appendix 1

Report read out to the A.G.M. by Ian Doolan.

Overview

Indoor Sports has enjoyed another successful year with increasing member attendance at the club with a current membership of 264 split between 182 gentlemen and 82 ladies. We have some data on age classification.

The Bar

The Club bar has provided a full range of alcoholic and non-alcoholic drinks which are chosen to match the demands of the club members. It is worth noting that several draft beers were stocked and changed during the year and the club was awarded the CAMRA Club of the Year Award for 2024.

The Hungerford Beer Festival

This was held at the Club this year on all three days of the August bank holiday weekend. In spite of the weather, it was the most successful to be held, featuring 14 draft ales and 3 draft ciders, supported by a running barbecue. Hundreds of people attended this event being entertained by live music groups on the Croft Green

It is noted that the bar takings for this event was £9,708 and the food were £1,390 – a total of over £11,000. The previous year's takings was £9,000. Compare these figures to the pre-covid figures of around £4,000.

Catering

Lunches, suppers and snacks have been served to order but due to limited kitchen facilities these are limited. It is hoped to increase the catering choice to the members in the future by promoting "steak", "curry" and "pizza nights".

The Bar Area

A plan has been approved to modernise the bar area to make it more workable for the bar staff, allow drinks to be better displayed and make the bar more attractive to the members. It is hoped that this work can be carried out early next year.

It is also felt that the members lounge area could do with brightening up which would help to attract younger members to join the club.

Sporting Activities

Snooker

Since the Covid lock down when the snooker room was closed, there has been a gradual recovery of use of the tables and it has not been until this year that usage level has reached pre-covid levels with a significant number of new younger members joining the club. The installation of the new red carpet has significantly improved the look of the snooker room.

It is hoped that the "Spoons" competition can be relaunched and the club can enter a team in the Newbury Snooker League.

Indoor Bowls

A few members have been playing this fun game recently – an ideal winter sport!

Darts

A Darts Team has been established with much enthusiasm which has entered the Lambourn Darts League. Results this year have improved thanks to some new signings and a great time has had by all, win lose or draw.

Cards

You can forget about having a quiet drink at the club on a Monday night, as the place is buzzing with the sixteen card players in spite of high levels of concentration.

Quiz and Bingo

These popular events have been held on alternative monthly Friday nights when the club is packed out.

Wii is an electronic game which has been recently established in the club and is proving popular.

Draws and Raffles

The meat draws have been held weekly along with the Easter and Christmas raffles, the tickets for all are always sold out

A Meeting Place

This Club has become a popular place for other local organisations to meet including the Bell Ringers, the Hungerford Allotments Association, the Book Club and not forgetting the Royal Antediluvian Order of Buffaloes. The recently introduced "Ladies that Lunch" is proving to be increasingly popular with all tables booked in advance.

Members have also made use of the club for private celebrations at times when the club is normally closed.

It is worth noting that the original purpose of the Hungerford Club when it was established in the Croft Hall in 1901 was to provide a meeting place for the young men of the town.
